Minor Trust Distribution 2025/IMPORTANT NOTICE

This information is for anyone who is overdue in rent, loans, family maintenance or any other monies owed to OIB's companies

- 1. If you are eligible to receive a distribution from OIB and your rent arrears, are over \$5000.00, your entire Xmas Distribution will be put toward your debt. If you are under \$5000.00 you must have a repayment plan in place with Housing Coordinator Jeddy Baptiste. (and be making regular payments)
- 2. If you have an open Family Maintenance file, your entire Xmas Distribution will be paid toward your debt, to Family Maintenance. (unless you can provide a letter from Family Maintenance that provides information that you are on a payment plan.)
- 3. If you owe any OIB Company, or have an outstanding Loan with OIB, your entire Xmas Distribution will go toward that debt.
- 4. Osoyoos Indian Band, Chief and Council, has been in consultation with OIB's Lawyers, regarding, Per-Capita Distribution for registered OIB members who are MINORS (18 and younger).
- 5. Chief and Council has decided (with legal advice), that it is in the best interest of all OIB Member Minor's, to place 100% of the Minors share of Distributions, Per Capita into their Minors Trust Fund, which is what most Bands do.
- 6. All Parents and Guardians will still be able to request a form (approved by Council) to withdraw funds, but, for specific purposes and limits only by doing the following.
- 7. Filling out an application, fully and completely and handing it to any Council member or Joanne McGinnis (accounting department). All withdrawal applications will be presented and approved at a regular Council Meeting.
- 8. The reasons for parents and guardians to request monies from the member child Trust Account, will be limited to Education, Medical and Sports.
- 9. If payments are approved, they will be paid directly to the provider of the service.

If anyone has any questions, please connect with a member of council on this matter.

Letter from Housing:

Just wanted to go over a couple items that I've learned over the last couple months attending workshops and that is mould prevention.

- -beds should be on frames and not just on the ground, with beds being directly on the floor there is no air flow.
- -piles/bags of clothes on the floor, anything in piles on the floor
- -blankets and or sheets on the windows, it is okay if there's a couple inch gap in between, if you use curtain rods, they are the best as they stick out a few inches from the window allowing air flow.

The key to not having mould build is airflow and if airflow is restricted bacteria can build up. One of the biggest mould producers is the bathroom, cause of the amount of moisture. Fan should always be on when showering or bathing, and if you have a bathroom window even cracking it a bit after showering. Even wiping down your shower afterwards with a towel. Cleanliness.

Another weekly home inspection that can prevent issues is checking under your sinks, (kitchen, bathrooms, laundry) and around the toilet if you can spot a small leak early can prevent mould/water damage, sometimes as simple as a new washer/seal. Also to check the caulking around shower and tubs

On another note, with septic systems, they are designed to only have toilet paper, wipes and feminine products aren't supposed to go down and will clog the system which will cause a back up and turn into thousands of dollars in damage that was preventable and from now on will be at the homeowner's expense if that happens.

Sedgwick PHOENIX COPPER-GOLD PROJECT RECORD RIDGE MAGNESIUM PROJECT

there are two significant mining projects in OIB lands. One is near Greenwood. This is the Phoenix Copper-Gold project. The second is near Rossland. This is the Record Ridge Magnesium project. OIB has the final say on both projects. Here are some quick bullets on each.

Phoenix Copper-Gold

- 1. This is an old mine that operated about 100 years ago at a place called Phoenix between Grand Forks and Greenwood.
- 2. The ownership changed over the years. The last owner went bankrupt.
- 3. Our partners, with the company name, Phoenix Copper, bought the project out of bankruptcy for about \$1.7 million US.
- 4. As part of their commitment to OIB, Phoenix Copper gave AT NO COST the OIB 51% of the project.
- 5. Phoenix Copper is now drilling on the site. This is ONLY exploration drilling. It could take a few years of drilling and some more work to find out if the mine has a chance of reopening. Some jobs are available. Its only summer work so far.
- 6. If the project is worth it, Phoenix Copper will seek permits and environmental assessment to build a new mine on the old site. This also take about two years minimum.
- 7. OIB is well positioned. OIB holds 51% of the company and has positions on the company board. So OIB will get revenue from this.
- 8. BUT also OIB, as the local First Nation government, also gets oversight over the permits and environmental assessment. If and when this happens OIB government will negotiate a benefit agreement with the mine for revenue, jobs, contracts, environmental oversight etc.
- 9. IN SUMMARY OIB is well positioned as a controlling interest in the mine, so OIB will make money as a business partner. But OIB is also the impacted First Nation government so OIB gets oversight over the environmental assessment and OIB would get revenue sharing (taxes) and the local First Nation government. Double benefit!
- 10. IF the mine goes ahead it will be a few years of preliminary work, then an environmental assessment, then construction. So its in the future.

Record Ridge Magnesium

- 1. This project will mine magnesium and truck it to a facility in the USA. This mine is not a hard metal mine and operates more like a gravel pit.
- 2. The mine is now in front of the BC Government's Mine Development Review Committee. This is the government body that permits it.
- 3. The mine owners have been respectful in consulting with OIB. The mining company paid OIB to do two studies. One was an environmental review and one was an economic review (will it make any money). So we have the results of both those studies where were positive.
- 4. OIB has an economic agreement with the mining company. OIB gets 3% of gross revenues (which is better than net revenues) up to a cap of \$3 million dollars per year. This agreement was signed in 2023. We also get \$40,000 in stock options. OIB also gets preferred employment and contracts. Right now OIB's JV partner Sutco is doing some work on site.
- 5. Construction cant start until the government approves the projects. OIB has been participating (through its consultants) in the permitting process.
- 6. When the mine opens, its only for 2 years as its considered a test. If the mine wants to run longer they will need new approvals to expand. OIB will have oversight over that approval.

In summary, neither mine is in construction yet. Both have a lot of things to do yet. BUT both have provided OIB with generous financial packages. OIB's goal here is to have mines that operate under OIB oversight but provide significant new revenue sources to the band.





This fully funded program is designed to prepare you for a meaningful career as an Education Assistant, working alongside teachers to support student learning and well-being. The program integrates culturally grounded practices and courses from the Indigenous Community Support Worker Certificate to expand employment opportunities and build stronger connections between schools and communities. Program delivery is in partnership with Indigenous communities and organizations in North Okanagan/Merritt, Central Okanagan, and South Okanagan-Similkameen.

The training program is comprised of:

- Education Assistant Certificate
- Indigenous Community Support Worker Certificate courses
- Industry certifications (includes FoodSafe, First Aid, Mental Health First Aid, Non-Violent Crisis Intervention)
- Resume writing, job search strategies and interview preparation
- 10-week work experience placement

Course Schedule:

Sept. 8, 2025 - March 20, 2026

*Foundational learning will be delivered online and supplemented with in-person training and cultural activities.

Participants eligible to receive training must:

- Have an active Employment Insurance (EI) claim, or had an EI claim that ended within the past 60 months; or earned over \$2,000 in insurable income and paid EI premiums in at least 5 of the last 10 years; or be a client of British Columbia Employment Assistance (BCEA), whether PWD (Person with Disabilities) or non-PWD, and
- Be eligible for WorkBC Case Management and be referred by a WorkBC Case Manager. *Priority will be given to Indigenous participants.






Osoyoos Indian Band Opening an Office in Grand Forks



Osoyoos Indian Purchases 2 Forestry Woodlots

A woodlot is an area-based forestry tenure that is entirely managed by the owner. The OIB has acquired two new woodlots each 1500 acres in size. Included in the acquisition is 160 acres of private land located by Jewel Lake (outside of Greenwood).



OK Falls Woodlot: this land was burned in the 2021 Thomas Creek fire but is being replanted with a diversity of trees and shrubs to improve wildlife habitat and regulate water flow. Restoration & recovery is the main focus on this woodlot, to bring this Land back into a resilient forest.

Jewel Lake Woodlot and Private Land: located just south of Jewel Lake, this forested land contains healthy trees, huckleberries, and a variety of wildlife. It is accessible from a forest service road and will provide OIB community members with the opportunity to hunt, fish, camp, and enjoy recreational activities. This working forest will provide jobs and generate revenue for the OIB for generations to come. Jewel Lake itself has a provincial park at the north end and cabins and boat rentals at the south end, while surrounded by hiking trails.
